



OPERATING REQUIREMENTS WAIVER

Victoria

Section 27 *Electronic Conveyancing National Law (Victoria)*

Title

This instrument is Victorian Operating Requirements Waiver OR 1/2024 – Interoperability Operating Requirements.

Enabling Provisions

1. Under sections 22 and 25 of the *Electronic Conveyancing National Law (Victoria)* (the National Law) the Registrar of Titles (Registrar) has determined and published Version 7 of the Operating Requirements which came into effect on and from 28 March 2024 (Operating Requirements). Capitalised terms used in this instrument and not defined have the meaning given to those terms in the National Law or the Operating Requirements.
2. Section 27 of the National Law permits the Registrar to waive compliance with all or any provisions of the Operating Requirements if the Registrar is satisfied that granting the waiver is reasonable in all the circumstances.

Affected Operating Requirements

Operating Requirements 5.2.2, 5.2.3, 5.2.4, 5.7, 5.8 and Operating Requirements 15.4(c) and 18.2 but only as they relate to the Category Three requirement to demonstrate compliance with Operating Requirement 5.7 (Affected Operating Requirements).

Explanatory Statement

Under the Victorian Electronic Conveyancing National Law Waiver ECNL 1/2022 – Interoperability Requirement, the Registrar has granted all ELNOs approved under section 15 of the National Law a total waiver of their obligation to comply with the Interoperability Requirement under section 18A(2) of the National Law (ECNL Interoperability Requirement Waiver).

The Operating Requirements contain requirements relating to Interoperability which until the ECNL Interoperability Requirement Waiver is revoked are neither required nor appropriate.

Accordingly, the Registrar has determined that it would be reasonable in the circumstances to grant a partial waiver modifying the obligations of ELNO(s) under the Affected Operating Requirements.

Waiver

Subject to the Conditions, the Registrar grants ELNO(s) a partial waiver of their obligations to comply with the Affected Operating Requirements.

Conditions

The partial waiver is granted on the condition that an ELNO complies with the Operating Requirements except for:

- (a) the Affected Operating Requirements; and
- (b) any other Operating Requirement except as the Operating Requirement relates to Interoperability.

Commencement

This partial waiver commences on 28 March 2024.


Period during which this waiver applies

This partial waiver operates until the earlier of:

- (a) the revocation of the ECNL Interoperability Requirement Waiver; or
- (b) ELNO(s) fully complying with the Affected Operating Requirements; or
- (c) the revocation of this waiver by the Registrar.
